To help you understand how the bail bonds process works, here are some of the commonly asked questions with their answers.

## How Does Our Bail Bonds in Hurricane UT Work?

---

First, a bail bond is an amount of money that an offender puts up in court to face the charges. If the defendant is held before trial, they are allowed to deposit a certain amount of money with the court, and this enables them to remain free. However, what happens when you cannot afford to post your bail?

This is where a bail bondsman steps in. A bail bondsman agent deposits the amount of money you require for your bail in exchange for a fee. ***This allows the defendant to post the bail amount they were not able to afford.*** Typically, Hurricane Bail Bonds agents, charge at least 10 to 15% of the bail amount required.

For instance, if the court requires a \$100,000 bail, the bail bonds agent may charge only \$10,000. In exchange, the bail bonds agent will pay the remaining \$90,000, allowing the offender to go free.

## What Do You Need to Know Before Contacting Hurricane Bail Bonds Agents?

---

Before you can contact a Bail bond agent in Hurricane Utah, you need to know the following information for them to help you.

- **Where is your relative/friend/loved one in custody?** Make sure you inquire about the location, and this includes the state, city, and name of jail.
- **What is the booking number and full name of the person in jail?** Our bail agents will require this information, as it helps them contact the jail. However, if you are not quite sure about the booking number, our bail bonds agents will get the number for you in case it is not available or you cannot remember it.
- **How much is the required bail amount? *If you do not have this information, a Bail bond agent in Hurricane Utah will acquire it*** once they contact the jail. With the amount required for bail, the bail bond agent will then tell you the amount of money you need to post a bond and the other requirements to get your friend/loved one out of jail.

## How Can You Get a Bail Bond?

The first way to get a bail bond is through the use of bail bonds hurricane Utah. ***A bail bond agent will avail the amount of money you require to post bail.*** This relieves you of the worry of having to put up your property with the court.
