How a Bail Bond in Tooele County, Utah Determined?

A defendant, soon after an arrest, is usually arraigned in court for the bail hearing session. ***The judge listens to the defendant's arguments and sets a bail amount that is appropriate to the case based on the severity of the alleged offense among other factors.*** The bail amount the defendant should post to get out of jail can be as low as \$100. Sometimes the bail amount set by the judge can be so huge for the defendant to pay in full.

At Bad Boys Bail Bonds in Tooele, Utah, we help individuals who can't manage to pay the full price of the bail amount, to stay out of jail. Also, we also become liable if the defendant fails to appear in court for the next hearing, on a specified date.
