Many people who are brought to jail prior to trial are given a bail amount that they can pay as collateral to be released from jail. **Essentially, the court determines an amount of money appropriate to the charges** (for example, the first offense of driving under the influence generally has a bail of \$1420,) and if you **pay 10% of the bail upfront**, you are released prior to your court date. However, if you or your loved one fails to show up for the court date, whoever paid the original 10% is liable to pay the remaining amount.

If you are having trouble coming up with the cash for bail, a bail bondsman at Bad Boys Bail Bonds is here to help. You will pay a small upfront fee and give us collateral against the full bail amount.
